Overcoming Challenges Building a Sustainable Future for NGOs in India

Non-governmental organizations (NGOs) play a crucial role in India's development and social progress, but they face several challenges in implementing their community development programs effectively. A recent study has highlighted some of the critical challenges that NGOs in India face and provided recommendations to address them.

Through a Public Private Partnership with the Municipal Corporation of Greater Mumbai (MCGM), Muktangan established its first primary school, nurturing four batches of students who have, without dropping out, in course of time, successfully cleared their SSC examination with an impressive average mark of 73%. These accomplishments can be attributed to the dedicated community teachers trained by Muktangan.

In 2011, the Dasra-created Giving Circle provided crucial funding for Muktangan's three-year teacher education program aligned with the 2009 National Curriculum Framework. This program was designed to immerse trainees as teachers in the classroom during their second and third years. The grant enabled the development of modules that were pilot-tested on subsequent batches of trainees. The success of these modules led to their presentation to senior educationists and government officials in Delhi, further reinforcing Muktangan's commitment to sharing their learnings and promoting positive change at a systemic level.

Bridging the Skills Gap: Learning from Germany's Dual Education System for India's NEP 2023
