
Engaging Resource Materials


Leveraging E-Content

Empowering Lives, Building Futures: Vipla Foundation's remarkable journey of social change

In an era marked with unequal opportunities, Vipla Foundation stands as a beacon of hope, striving for the last 35 years, to transform the lives of children and women from the underserved communities. With a structured approach and a visionary outlook, Vipla foundation is a driving force of change; empowering young minds and creating a bright future for all.

Vipla Foundation (registered as Save The Children India) works in four thematic areas of Early Childhood Care, Education, Inclusion and Women Empowerment. Their programs are founded on two major pillars – Early Interventions and System Strengthening. Vipla Foundation strives to ensure holistic development of young children so that they can reach their full potential and become effective contributing members of society.

Their intervention in Early Childhood Care encompasses numerous Balwadi centres across Mumbai, Navi Mumbai and Ahmedabad as well as Anganwadi centres where they conduct teacher training programs and curriculum design and implementation for a robust and equitable development and learning opportunities for children from vulnerable communities. The key element of their Balwadi Mentoring Program is individual attention and coaching mentoring support to each teacher, developmentally appropriate curriculum and building capacity within the community thereby enabling and elevating the learning curve among young children. Their Patang Remedial Education Program is focused on improving grade-level competencies of children who are lagging behind. Through their School Transformation Program, they work towards advocacy and supporting systemic change in school eco-systems bringing together all the stakeholders, including the community they operate in.

The Special Care Centre, a school for children with hearing impairment and intellectual disabilities focuses on providing quality education and all-round development of children so that they can go on to lead a life of dignity and economic independence. Operating through a well-structured framework, Vipla Foundation lays emphasis on holistic development, education, and skill-building of children, equipping them with tools to build their future and lead them to a life of financial independence, thereby enabling them break the shackles of poverty. Part of the inclusion program is the Dhvani Early Intervention Centre that provides timely intervention to children with hearing impairment.

The impact of Vipla Foundation's work can be witnessed through its numerous success stories of change and the accolades it has received over the years. In the past one year itself, it has reached more than 50,000 children directly and indirectly through their various interventions of Early Childhood Care, Patang Remedial Education Program and the Special Care Centre. The program benefited children in their holistic and academic progress which is evident from different indicators tracked for each set of children. In the Balwadi program (children aged 4-6), 85% children were deemed 'School Ready' according to SRI (School Readiness Index) tool (adapted from the World Bank SRI tool). In the Patang program, 80% children showed improvement in their learning levels in Language and Math. In the Special Care Centre, 8 children with hearing impairment had appeared for 10th board exams in March 2023 and 100% of them passed with scores more than 65%.

Vipla Foundation's comprehensive approach has had a significant impact on the lives of children and women from the vulnerable communities. From humble beginnings in a small room in YMCA, Andheri in 1988 to now operating across five states in India, Vipla Foundation has grown leaps and
