According to Vivekananda, education is the assimilation of ideas. It is not the amount of information that is put into your brain and runs riot there, undigested all your life. Education must equip students. The education that does not help the common mass of people for the struggle for life, which does not bring out strength of character, a spirit of philanthropy and the courage of a lion – Is it worth the name, he asks?

He says, "We want that education by which character if formed, strength of mind is increased, intellect is expanded, and by which one can stand on one's own feet. The end and aim of all training is to make the man grow (man making), by which the current and expression of will are brought under control and become fruitful is called education. Further, we must have life building, character making education. If you have assimilated five ideas and made them your life and character, you are more educated than any person who has got by heart a whole library."

### How should students learn

According to Swami Vivekananda, "Knowledge is inherent in man no knowledge comes from outside. Therefore, knowing means discovering or unveiling. Infinite power is in the soul. The whole of the big banyan tree was in the little seed. The manifestation of power inside man is a question of being conscious of it. He gives the example of Newton's discovery of physical laws from a falling apple, and says that Newton had only uncovered the knowledge in his brain with a nudge from the environment or falling apple. Thus, a child teaches itself. What we can do is a kind of support that is of a negative nature like taking away the obstacles. Students must learn to apply their intellect, give them free scope for growth.

Further, concentration is the only method to attain knowledge. The very essence of education is concentration of the mind, and not the collection of facts. What we want is Shraddha, faith in our own selves must be reawakened and all the problems we face will be gradually solved by ourselves. What a grand vision he had on education and learning! ## Empowering Minds: E&H Foundation's Journey Towards Quality Education

In the heart of Uttar Pradesh, E&H Foundation has emerged as a beacon of hope for thousands of children, breaking barriers and transforming lives through the power of education. Since its inception, the foundation has been on a mission to provide quality education to underprivileged children, with a strong emphasis on bridging the gender gap in literacy. Let's delve into the inspiring journey of E&H Foundation, its accomplishments, and its vision for the future.

E&H Foundation has left an indelible mark on education in three districts of Uttar Pradesh - Farrukhabad, Kanpur, and Lucknow. With a focus on children from Standard 1 to 5, the foundation has successfully reached out to over 19,000 students, with an encouraging 55% being young girls. This commitment to empowering female students contributes significantly to narrowing the gender literacy gap not only in UP but also on a national scale.

Independent studies have consistently showcased the remarkable achievements of students under the E&H Foundation's wing. These young minds have not only excelled but have often outperformed their counterparts in government schools. Surprisingly, their academic performance rivals that of students in India's premier CBSE schools, all achieved at a nominal cost of ₹5000 per child per year. This success creates a powerful case for scaling up the program, aiming to impact 100,000 children by 2025.

Over the last half-decade, E&H Foundation has achieved significant milestones. More than 80% of the students are first-generation learners, with 50% being girls, breaking the cycle of educational deprivation in their families. Independent assessments by Education Initiative have demonstrated that E&H Foundation students perform on par with the best CBSE schools in India. The foundation has also forged partnerships with over five corporate houses, including BlueDart, HDFC, InfoEdge, and garnered support from more than 500 individual donors to fund their impactful programs.



In the academic year 2018-2019, E&H Foundation showcased its commitment and effectiveness through two key models. Under Bharti's model, the foundation supported the education of 720 children in three operational schools in Farrukhabad, with two students earning the distinction of being shortlisted for Shiv Nadar School at the 6th-grade level. Implementing Gyanshala's MIT approved pedagogy, E&H Foundation ran 237 classes in over 100 slums across two districts, impacting approximately 6200 children, half of whom were girls.

In the Gyanshala model, E&H Foundation achieved remarkable success. They maintained a cumulative average attendance of 66%, surpassing the recorded average attendance in government and private schools during the same period. 85% of enrolled students participated in final examinations, with 72% scoring above 80% marks, showcasing the efficacy of the program. The foundation achieved grade-appropriate learning for at least 70% of children, highlighting its commitment to academic excellence.

Teachers, supervisors, and core team members actively participated in training and capacity-building workshops, fostering community engagement and parental involvement. The program not only enhanced student learning but also cultivated a deeper understanding among parents about the importance of continued quality education.

E&H Foundation's journey has been marked by dedication, passion, and a relentless pursuit of transforming lives through education. With a track record of academic excellence, gender inclusivity, and community engagement, the foundation stands poised to realize its ambitious goal of reaching 100,000 children by 2025. ## Harmony in Learning: eVidyaloka's Collaborative Journey with Vidya Poshak Illuminating Rural Education

In the quest to transform the education landscape in rural and remote parts of India, eVidyaloka Trust stands as a beacon of change. Established in 2010 and registered as a non-profit organization in Bangalore, Karnataka, in 2011, this initiative is not merely an educational platform; it is a commitment to addressing the chronic challenges that hinder the quality of education in rural schools.

eVidyaloka takes a holistic approach to two major hurdles affecting education quality in rural India – the shortage of teachers and the need for enhanced teaching quality. The model is ingeniously designed to connect qualified Indian nationals residing in over 110 cities with students in the remotest villages. Leveraging technology, the platform ensures access to high-quality teachers for children in rural to tribal regions, catering specifically to those in the age group of 10-14 (6th to 8th grade).

The live interactive classes, conducted in local languages, create a powerful learning environment, bringing a ray of educational sunshine to areas where it is needed the most. The initiative has formed a robust partner ecosystem, making education accessible to children who would otherwise lack quality learning opportunities.

One remarkable collaboration that exemplifies the impact of eVidyaloka is with Vidya Poshak, focusing on four villages in Dharwad taluk since 2015-16 and 2016-17. The partnership aims to empower children in the age group of 10-14 (6th to 8th grade) from government schools at Managundi, Benakanakatti, Baad, and Mugad.

Operated with the consent of the Department of Education, Government of Karnataka, the program involves active participation from the School Development Management Committee (SDMC), parents, school staff, and class assistants. A total of 480 children are benefitting from this collaborative effort, showcasing the positive impact that thoughtful partnerships can bring to rural education.

eVidyaloka's model not only adheres to the State Board curriculum but goes above and beyond by incorporating digital media content like videos, visual flows, pictures, and activities. This approach enriches the learning experience, allowing students to visualize and grasp complex concepts, thereby inspiring a higher level of engagement in the teaching-learning process.

The sessions are seamlessly integrated into the school hours, ensuring that education becomes an integral part of the students' routine. Additionally, eVidyaloka conducts tests at the beginning of the school year and semester-wise exams, providing a structured evaluation framework to assess the progress of each student.

The collaboration between eVidyaloka and Vidya Poshak epitomizes the transformative power of education when combined with innovative models and strategic partnerships. As eVidyaloka continues to extend its reach and impact, the vision of quality education for every child in rural India becomes increasingly attainable. The partnership serves as a testament to the belief that through collective efforts, we can overcome barriers and illuminate the path toward a brighter, more educated future for the children of our nation.
